**6 YEAR OLD HISPANIC/CAUCASIAN/ASIAN BOY**

This situation comes to us from an advertising company so there is a fee for their services.

This little boy was legally adopted by his biological grandmother. The grandma is now in her late 60's and doesn't feel she can provide an ideal life for her grandson as she is getting older and just doesn't have the energy to raise a young child in the way she wants for him. Grandma is gathering updated medical records for the child and school information including his IEP. He is just finishing up his Kindergarten year of school. He attends a charter school where he enjoys math and reading.

Grandmother requires a Christian couple and would like a family with children close to her grandson's age, but she is open to adoptive parents with younger/older children as well as those with no other children. Grandmother would like to stay in contact with her grandson through mail, phone calls and visits. She states she would not be co-parenting but definitely wants to be part of his life.

She wants an active and energetic family where her grandson would be loved and accepted as their own. She says her grandson is very loving, caring and sensitive. He's also very talkative and outgoing. He wants to meet and talk to everyone he encounters. He makes friends very easily, both children and adults. He is very active and the pediatrician thinks he may have ADHD. The child also suffers from seasonal allergies and possible anxiety and behavioral issues. His biological mother did use drugs during her pregnancy but we do not know which drugs. We do not yet have a schedule of how the transition will occur but we expect to work on that once we have a family in place.

We have met with both the grandmother and grandson. Grandma is a very kind and patient lady who loves her grandson tremendously. This breaks her heart to place him with another family but she knows it is in his best interest. Her grandson is very inquisitive, friendly, enjoys attention, and likes to keep very busy. He will do well in a family that can provide plenty of love, patience, guidance and activities to keep him occupied.

# Adoption Cost & Fee Breakdown

## Cost - More Details

COST OF THE ADOPTION – CALIFORNIA FINALIZATION – **California Families. Estimated at or about \$33,000** to include an advertising service fee, case management and legal fee, ICPC fee, initial costs deposit, and payments to third party providers. Third party providers include the adoption service provider, independent counsel, and State of California, Department of Social Services.

COST OF THE ADOPTION – **NON-CALIFORNIA FINALIZATION** – Families outside of California Estimated at or about \$21,800 to include an advertising company service fee and limited case management/legal fee to our office.

PLEASE NOTE: For an out of state finalization, our office will not be involved in managing the case or handling the legal portion of the case. You will need to finalize in either your home state or state where mother resides. You will be required to obtain an attorney and/or agency in addition to any third-party providers as needed under the law of the state where finalization will occur.

We are unable to quote the cost for those items in another state. We are also unable to say what your state allows for payment of birth mother living expenses. You will need to add the cost of any fees, costs and expenses in either your state or birth mother's state to the estimated cost we provide.

Since this is an older child and transition may take place over the course of a couple months, families need to be prepared to make some trips to Arizona, which is the child's state of residence.

If you do not have the total amount required for this adoption available, AFMC recommends that you get PRE-APPROVED for an adoption loan BEFORE you submit for this or any other situation that exceeds your current budget to make sure the adoption will not fall through due to an inability to pay.

## REQUIRED

- A completed **US Domestic Private** home study
- A PDF profile no more than 12 pages (including cover page) about your family with no contact information listed inside.\*\*\*  
**(IMPORTANT: a link to an online profile WILL NOT be accepted)**
- **An active membership** with AFMC  
(membership options start at \$0 per month)
- Complete AFMC's "New Member Questionnaire"  
(provided after you register for a membership)
- Read and sign AFMC's Service Agreement  
(provided after "New Member Questionnaire" is completed)

## OPTIONAL

- Letter to Expectant Mother  
(providing one is highly encouraged, but not required)
- Family Interview Video
