tobacco 2 packs daily, no drug use or Alcohol use. medical background; depression, anxiety, high blood pressure, nightmares and asthma

Why Adoption: give my child a good home and the family that can give the support that i am not able to.

\*\*Coordinator has provided the following info.

Proof of pregnancy. SP has placed 3 other children in the past. Mom has a past history of drug use, but states she is clean, but reports tobacco use. She stated she smokes 2 packs a day. She has been in and out of abusive relationships with the babies father for many years. She doesn't want counseling and know how adoption works due to placing her past three children. She is hoping to find a family that will not judge her on the life she has chosen or intrude with her relationship. She is a super sweet girl, but does need support with expenses.

Birth Father knows about the pregnancy and adoption plan and supports her choices. She is an open book and communication comes easy once she gets to know you.

#### **Additional Information:**

We have a case manager in Kansas that has met with her and is able to work with her. Reports no drug exposure and that she has been clean for 15 months.

We cannot give you an estimate on the cost cost will determined from the attorney/agency you hire to complete the adoption.

What does private adoption mean. When an expectant mother comes to our site and she is not working with an agency or an attorney. She can select a family in the family would have to cover the cost for her attorney their attorney unless they are working with an agency, and any Birth mom expenses that she will have.

Estimated cost would include: Independent adoptions can range in fees. Our system has estimated this adoption to be around 20k, to 25k.

- An active membership with AFMC (membership options start at \$0 per month)
- Complete AFMC's "New Member Questionnaire" (provided after you register for a membership)
- Read and sign AFMC's Service Agreement (provided after "New Member Questionnaire" is completed)

## **OPTIONAL**

- Letter to Expectant Mother (providing one is highly encouraged, but not required
- Family Interview Video
