Additional Information:

Mom is a 23 year old Native American/Caucasian that is healthy. She does suffer from depression and anxiety. Mom was born with strawberry blonde that has progressed to a chestnut brown, with Hazel eyes. She is petite 5'2 and before pregnancy 124 lbs.

Father is 29, Caucasian with black hair and green eyes. He is 6' tall and weighs about 175 lbs. He is healthy and experiences un-diagnosed anxiety/depression.

Mother and Father live together - they are no longer a couple and mom is seeking housing options. (Case Manager has very affordable options she will be discussing with her)

Father knows and supports adoption plan

Mom was going to get an abortion, but was too far along for abortion to be an option. Mother has not been receiving any prenatal care. She has applied for Medicaid and doctors appointment has been made for her to get up to date medical and ultrasound.

Case Manager in Kansas will be providing services and support for this expectant mother.

The following is her words.

WHY ARE YOU CHOOSING ADOPTION?

I do not feel I had very many options even when just finding out I was pregnant. It became clear quickly I was not going to be able to properly care for the child, AND myself. My "partner" wanted NO part in any of it. At this point adoption might save my life.

PLEASE DESCRIBE THE LEVEL OF OPENNESS YOU WOULD LIKE TO HAVE WITH THE ADOPTIVE FAMILY: I do not know yet. I feel very indifferent about everything going on right now. I am not questioning the fact I know I cannot care for the child, or that I may end up wanting to keep the child. I am questioning my actual strength to survive and live a healthy life after the emotional trauma I've encountered this past year. Being able to maintain contact at my own discretion would be best for me at this time.

The following is a handwritten short list of things I really would like to see in the adopting family..

Adoption Cost & Fee Breakdown

Cost - More Details

This situation is estimated to be between 15,000 and \$20,000

Mom is meeting with a case manager in Kansas. We have worked with this case manager in the past and she has not provided us her fees for this case. Case management fees can range from \$4,000 to \$6,000 depending on the level of need for the expectant mother.

We cannot give you an estimate on the cost cost will determined from the attorney/agency you hire. to complete the adoption.

What does private/independent adoption mean. When an expectant mother comes to our site and she is not working with an agency or an attorney.

The adoptive parents are financially responsible for:

- Medical expenses of the birth mother and child in relation to prenatal care, pregnancy and birth
- Reasonable living expenses for the birth mother to support her during the pregnancy, which may include help with rent, bills, groceries and more
- The birth parent(s)' attorney fees

Expenses paid by the adoptive parents to the birth parent(s) are determined on a case-by-case basis, and those requested expenses must be deemed reasonable by a Kansas judge. Some expectant mothers will have greater financial need than others, so it's reasonable that their necessary living expenses may be greater.

TOTAL ESTIMATED COST OF THE ADOPTION: \$15,000.00 - \$20,000

***Funds are due within 48 hours of being selected by the expectant mother.** Under NO circumstances should you submit your profile or request to be considered **UNLESS** you have the ability to immediate access to the liquid

funding necessary to pay the upfront fees listed above. Please be realistic in regards to your ability to pay the total estimated cost of the adoption by the time the expectant mother delivers her child. If you do not have the total amount required for this adoption available, AFMC recommends that you get PRE-APPROVED for an adoption loan BEFORE you submit for this or any other situation that exceeds your current budget to make sure the adoption will not fall through due to an inability to pay.

- A completed **US Domestic Private** home study
- A PDF profile no more than 12 pages (including cover page) about your family with no contact information listed inside.***
(IMPORTANT: a link to an online profile WILL NOT be accepted)
- **An active membership** with AFMC
(membership options start at \$0 per month)
- Complete AFMC's "New Member Questionnaire"
(provided after you register for a membership)
- Read and sign AFMC's Service Agreement
(provided after "New Member Questionnaire" is completed)

OPTIONAL

- Letter to Expectant Mother
(providing one is highly encouraged, but not required)
- Family Interview Video

NOTE: All documents must be formally approved by AFMC before you can request to have your profile sent to the expectant mother.)
