BIRTH MOTHER PLACING HER 12 WEEK OLD AFRICAN AMERICAN/CAUCASIAN BOY

This situation comes to us from an advertising service so there is a fee for that company. Advertising service charges\$15,800 of which \$7,900 is refundable if mother changes her mind.

#### **BIRTH MOTHER INFORMATION**

Birth mother is placing her 12 week old baby for adoption. She is 37 years old and has 3 other children that do not live with her. She says she doesn't use drugs, drink alcohol, or smoke cigarettes and did not use any substances during the pregnancy. She loves her baby but is unable to support him in the manner he deserves. She says she has been diagnosed with bi-polar disorder and PTSD. She currently lives in Wisconsin.

#### BIRTH FATHER INFORMATION

Birth father knows about the child but doesn't know that she is considering adoption. We are in the process of providing notice of the adoption planning to see if he will try to stop an adoption plan. So, anyone presenting for this case needs to be aware that the birth father situation could be an issue. Mother believes he won't cooperate but doesn't think he would fight an adoption plan.

#### REQUIREMENTS FOR ADOPTIVE PARENTS

She is open to most adoptive parents. It is very important for her that at least one parent is African American. She is open with regard to age, location, and other children but prefers a Christian family. She also requires a family that will agree to 3-4 visits (in person) per year. The visits are non-negotiable for her. Please do not apply for this situation if you are not able or willing to commit to this. Mother will only accept adoptive parents from states where there is an enforceable contact after adoption agreement.





- An active membership with AFMC (membership options start at \$0 per month)
- Complete AFMC's "New Member Questionnaire" (provided after you register for a membership)
- Read and sign AFMC's Service Agreement (provided after "New Member Questionnaire" is completed)

### **OPTIONAL**

- Letter to Expectant Mother (providing one is highly encouraged, but not required
- Family Interview Video
