The Birth Mother is a registered Choctaw individual, and she hopes to find a registered Native American family from any tribe. It is essential for the family to have a registered member. She specifically requests a family that actively embraces and upholds the Native American lifestyle and traditions.

As for the Birth Father, he remains unknown as he was the result of a one-night stand. The Birth Mother believes he is also likely to be of full Native American descent. She is 19 years old and currently resides with her parents, who are supportive of her adoption decision. She graduated with honors from high school, ranking at the top of her class. She received numerous grants to pursue her college education, which she plans to continue after her pregnancy.

Physically, the Birth Mother has a medium build, weighing 160lbs and standing at 5'8". She has black hair and brown eyes. There has been no exposure to drugs, and she has no history of mental health issues. She began receiving prenatal care in June 2023 because she concealed her pregnancy until after graduation. The baby, a girl, is developing well. Estimated due date: 11-12-23.

The Birth Mother desires an open adoption arrangement that includes exchanging photos, videos, and letters with the adoptive family. However, she currently doesn't anticipate wanting in-person visits.

- Read and sign AFMC's Agreement Contract - signed copy uploaded to your account.
